

**CORNERSTONE CHURCH
PRESCHOOL Re-Entry Plan
2020-2021 School Year**

August 5, 2020

IMPORTANT NOTE: Ideas and plans subject to change frequently as new information comes to us from Indiana & Spencer County Health Departments and the Center for Disease Control . The purpose of this planning is to keep our students and staff safe.

THIS PLAN IS SUBJECT TO CHANGE AS NEEDED BASED UPON THE DATA AND INFORMATION AVAILABLE TO US AS THE SCHOOL YEAR PROGRESSES

A. Initial Comments on Preschool Re-Entry: Opening Schedule as planned on September 1, 2020 with plans and precautions for social distancing, temperature monitoring of staff and students daily, wearing masks, use of hand sanitizer, disinfection of rooms, furniture, bathrooms, kitchen and hallways during the course of the day and after students depart from school.

B. Water Fountains Drinking fountains will **not** be available for use. Small disposable bottled water will be made available for each student daily.

C. Indoor Air Quality: O2 Prime™ air quality systems have been installed in the Church air handlers to clear the air of viruses, bacteria or molds. The O2 Prime™ air quality systems use a precise electronic charge to create an electrical field filled with high concentrations of ions. When these ions are injected into the air stream they break down passing pollutants and gases into harmless compounds like oxygen, carbon dioxide, nitrogen, and water vapor. When these ions come in contact with harmful pathogens such as virus, bacteria, or mold, they steal away hydrogen molecules from the pathogens. Without hydrogen, the pathogens are left without any source of energy to carry on and they die.

D. Classroom Set-Up Student seating will be spread out to the greatest extent possible with classroom furniture arrangements. Mobile Workspace partitions may be utilized when social distancing and/or face coverings are not reasonable. Auditorium/Gymnasium - limit capacity to allow for greater spacing, Hallways and Passing for Activities: Students will wear masks and social distance

Transportation**

Van Cleaning prior to transportation of students and ongoing cleaning and disinfecting commonly touched surfaces in the vehicle at the beginning and end of each day and between transporting passengers who are visibly sick.

F. Student Distancing / Limiting face-to-face contact with others is the best way to reduce the spread of coronavirus disease 2019 (COVID-19). Social distancing, also called “physical distancing,” means keeping space between yourself and other people outside of your home. To practice social or physical distancing: Stay at least 6 feet (about 2 arms’ length) from other people.

G. Church Van Seating (Student Distancing) • To the greatest extent possible, students shall be spread out on the van to limit physical and face to face contact. When possible, only household members will share seats. Drivers will be required to wear masks and/or face shields when distancing is compromised as students load and unload. Drivers may remove face coverings to drive as necessary. Students will be required to wear face covering.

H. Personal Health, Self -Care, Parent & Visitor Entry

1. Preschool will not have volunteers in the building. All students will be dropped off at the front doors of the church. Preschool staff will be at the door to screen temperatures and move students to the classroom. Parents will not be entering the building for dropoff or pick up of students.

2. Pre - Screening at Building Entry • Adults requesting to enter the main building will be “pre-screened” with a series of questions before being allowed to enter. School staff will determine approval for entering the building on a case by case basis.

3. Preschool staff and any other individuals entering the building will be temperature checked. 4. Individuals with a temperature of 100.4 degrees fahrenheit or greater will not be allowed entry into the building.

I. Screening to Re-Enter Students returning from a COVID-19 positive test, or having a fever of 100.4 or greater, will be transported to school by parent/guardian for screening prior to entering the building. Masks must be worn until the temperature scan is complete. Repeated temperature screening will occur approximately every hour following re-entry during the first 3 school days back in the building. Individuals with a temperature of 100.4 degrees fahrenheit or greater will NOT be allowed re-entry into school for a minimum of 72 hours.

J. Reporting and Handling of Suspected COVID Cases The Spencer County Health Department in collaboration with the State Health Department, handles recording of all official COVID cases. When there is a confirmation that a person infected with COVID-19 was in school, the school will contact the local health department immediately.

K. Direct Contact Tracing Direct contact tracing will be done in collaboration with the County and/or State Health Department. The state health department, county health department or school officials can make the call for a student or staff member to be quarantined due to direct contact.

L. Re-Entry after COVID-19 Diagnosis Re-Entry For Persons with COVID-19 Under Isolation: The decision to discontinue home isolation for persons with confirmed or suspected COVID-19 should be made in the context of local circumstances. Cornerstone Church Preschool Staff, will work in conjunction with the Spencer County Health Department regarding Covid-19 “positive” persons.

M. Quarantine Implementation Cornerstone Church Preschool will work in conjunction with the Spencer County Health Department regarding Covid-19 “positive” persons and persons reported in direct contact.

N. Hand washing/Sanitizer Usage Hand washing instructions will be taught and reinforced several times throughout each school day.
